

CONSIGNEE LETTER OF ASSURANCE GLOBAL TRADE COMPLIANCE

We acknowledge that the products, software, and technology of DwyerOmega (Dwyer Instruments, LLC (Dwyer), Omega Engineering, Inc. (Omega), Automated Components, Inc. (ACI) and Miljoco/Weiss, LLC. (Miljoco)) are subject to regulation by agencies of the U.S. government including, but not limited to, the Export Administration Regulations (15 CFR 730-774) as administered by the U.S. Department of Commerce and the regulations of the Office of Foreign Assets Control (31 CFR 500-599) as administered by the U.S. Department of the Treasury.

We agree in advance to the following:

- (i) We will take actions necessary to become informed, and inform our customers as needed, of the above-referenced U.S. export regulations, as they exist now or as they may be amended in the future, and agree to comply with said regulations as applicable.
- (ii) We will not re-export, transfer, or divert any DwyerOmega products, software, or related technology, directly or indirectly to any country, or to any national or resident thereof, without first obtaining, if so required, all export licenses, authorizations and/or approvals from the U.S. Department of Commerce and other appropriate U.S. and foreign governmental agencies.
- (iii) We will not engage in activity related to the development, production, use, testing, or maintenance of Weapons of Mass Destruction, as defined by the U.S. Department of Commerce, including without limitation, uses related to nuclear, missile, chemical or biological warfare. Nor will we knowingly re-export, transfer, or divert directly or indirectly to any party engaged in such activity.
- (iv) We will not engage in, or knowingly sell to any party engaged in activity related to the development, production, use, or maintenance of any safeguarded or unsafeguarded nuclear fuel facility or components for such facilities as follows:
 - a. Facilities for the chemical processing of irradiated special nuclear or source material;
 - b. Facilities for the production of heavy water;
 - c. Facilities for the separation of isotopes of source and special nuclear material; or
 - d. Facilities for the fabrication of nuclear reactor fuel containing plutonium.
